**NOTIFICATION**

In supersession of Notification No. IDCO/S&IP/295/2013-07 dated 10.01.2017 regarding industrial land rate i.e the rate at which land will be allotted in PPPL at Paradeep for establishment of industries is hereby revised in the following manner:

1. The land will be allotted @ Rs. 40.00 Lakhs ( Rupees Forty Lakhs) per acre in the Plastic Park Limited at Paradeep for establishment of industries.
2. It is further notified that this is an "Early Bird Discount" for allotment of land to the project proponent / entrepreneurs who are allotted land within (1) one year from the date of issue of this notification.
3. Additional 3% (Three percent) to be charged over and above the basic price for plots bounded by roads on 2 (Two) sides.
4. Additional 7% (Seven percent) to be charged over and above the basic price for plots bounded by roads on 4 (Four) sides.


