As per the decision taken by Government and communicated vide Letter No. 10065 dt. 21.10.2022 of Industries Department, Govt. of Odisha, it is hereby notified that the Annual Infrastructure Maintenance Charges (IMC) payable by the MSME Units for the year 2021-22 is waived herewith for all MSME Units of the State located in different Industrial Estates / Areas of IDCO with the following stipulations –

- i. This Circular is effective retrospectively from 01.04.2021 to 31.03.2022.
- ii. Those who have already paid the IMC dues online, such amount will be adjusted against the next year dues.
- iii. The respective Divisional Heads are hereby instructed to work out the IMC dues of the MSME Units.
- iv. This exercise will be taken up for all registered MSMEs in Go-iPAS portal.
- v. This shall be applicable for existing operational units and not be applicable for new allotments & post allotment services like Transfer, Revocation of Cancellation etc.
