Department, Government of Orissa at Bhubaneswar”**. The Chief General Manager (P&C), IDCO, IDCO Towers, Bhubaneswar invites sealed offers in prescribed bid documents from the ‘B’ and ‘C’ Class Contractors registered with State PWD / CPWD / Railways / MES and IDCO vendors of range Rs.10.00 lakh to Rs.100.00 lakh to be received through Speed Post only **by 03.00 PM on 20.07.2010**. The technical offer will be opened **on 21.07.2010 at 11.30 AM** in the office of the Joint Manager (Civil), IDCO, IDCO Tower, Bhubaneswar in presence of the bidders or their authorized representatives who wish to attend .The financial offer will be opened only of the technically qualified bidders after scrutiny of the Technical Bids **on 24.07.2010 at 11.30 A.M.** If the office happens to be closed on the date of last sale / receipt / opening of bids as specified, the bids will be sold / received /opened on the next working day at the same time and venue. **The bid documents can be available from the Office of the undersigned on payment of non refundable amount of Rs.6,400/- (Rupees six thousand four hundred) or can be down-loaded from IDCO’s website www.idco.in from 12.07.2010 to 17.07.2010.**

The Intending Bidders downloading the bid documents through internet should submit a Bank Draft for Rs.6,400/- (Rupees six thousand four hundred) only drawn in favour of Orissa Industrial Infrastructure Development Corporation payable at Bhubaneswar, without which the bid document will be liable for rejection.

The Intending Bidders have to enclose a separate Bank Draft of Rs.30,000/- (Rupees thirty thousand) only in favour of Orissa Industrial Infrastructure Development Corporation payable at Bhubaneswar as security deposit to be retained with IDCO for a period of one years or validity of the contract which ever will be later.

The Intending Bidders must enclose the attested copies of IDCO Vendor / Valid Contract License, Valid PAN, Clearance Certificate on VAT-612 and Valid EPF Registration Certificate. The selected vendors are required to be in readiness for execution of work on short notices as and when required during the validity of the contract.
