OFFICE ORDER

Whereas, Housing and Urban Development Department, Government of Odisha, vide Letter No. 1549 dated 27.01.2021 declared IDCO as Special Planning Authority for the Industrial Estates under the jurisdiction of IDCO in accordance with the provisions of Section 3A of the Odisha Development Authorities Act, 1982, in respect of such Special Planning Areas and subsequently Housing and Urban Development Department, Government of Odisha, vide Letter No. HUD-TP-POLICY-0004-2020-196 dated 03.01.2026, declared IDCO as Special Planning Authority for existing and upcoming Industrial Estates(IEs), Industrial Areas(IAs), Industrial Parks(IPs), Industrial Clusters(ICs), MSME Parks, Land Banks under the jurisdiction of IDCO in accordance with the provisions of Section 3A of the Odisha Development Authorities Act, 1982, in respect of such Special Planning Areas.

And whereas, as per Rule No- 90 of Odisha Development Authorities (Planning and Building Standards) Rules-2020, following are the charges of compounding fees.

Sl. No.	Situations / Limitations	Compounding fee for Sqm (in Rs) of deviation
1	Where development has been undertaken in deviation to the approved plan, but within the framework of use, restrictions and the provisions of norms and stipulations of these regulations.	Rs 300
2	Where development has been undertaken without permission, but within the framework of use, restrictions and the provisions of norms and stipulations of the regulations applicable to the concerned plot.	Rs 500
3	Construction up to 5% beyond the permissible norms of these regulations with respect to front, side and rear setbacks.	Rs 2,000
4	Construction from 5% to 10% beyond the permissible norms of these regulations with respect to front, side and rear setbacks.	Rs 5,000

And whereas, in the amendment of Odisha Development Authorities (Planning and Building Standards) Rules-2020, notified by H&UD department Odisha on 09.06.2025, the Rule No-90B was inserted stating that-

"IDCO shall be competent, in respect of such Special Planning Areas for which IDCO has been declared as the Special Planning Authority, to exempt industrial buildings from payment of any compounding fees, if the construction is within the limits prescribed under sub-rule (3) of 90 ".

Now, therefore, the conditions for providing exemption on compounding fees for Industries under the jurisdiction of IDCO SPA is as stated below:

1. The project proponent (allottee) should have applied for building plan approval of their industrial building to IDCO-SPA before starting the construction.
2. For obtaining Building Plan Approval from IDCO SPA, the project proponent (allottee) shall submit the Fire Recommendations from the Fire Department along with application and also submit Consent to Establish (CTE) from OSPCB (Wherever applicable) and Environmental Clearance from SEIAA (Wherever applicable) before issue of Building Plan Approval.
3. No exemption of compounding fees for industries in the Negative Sectors as per Annexure III of Odisha Industrial Policy Resolution (IPR) 2022 notified by the Industries Department, Government of Odisha, read with amendments from time to time, as long as the policy is in force.
4. No exemption of compounding fees for industries in the Negative Sectors as per Annexure II of Odisha MSME Development Policy 2022 notified by the Micro, Small & Medium Enterprises Department, Government of Odisha, read with amendments from time to time, as long as the policy is in force.
5. No exemption of compounding fees for industries falling under the Comprehensive Development Plan Area of Bhubaneswar and Cuttack.
6. Full exemption of compounding fees for Micro and Small Enterprises meeting the criteria as per point No. 19 of Annexure I of Odisha MSME Development Policy 2022 notified by Micro, Small & Medium Enterprises Department, Government of Odisha. (Udyam Certificate to be submitted along with other relevant details justifying that the unit meets the criteria).

7. For the cases not falling in paras 1 to 6 above, compounding fees for the Industries shall be decided by the DP&BP (Development Plan and Building Plan) Committee of IDCO SPA on case to case basis.

This order supersedes previous order No. 5263 dated 21.02.2026 and shall remain in force till 31st March 2027. Thereafter its continuation shall be subject to renewal.
