CIRCULAR

SUB: RATIONALIZATION OF DAMAGE CHARGES AFTER CANCELLATION OF THE ALLOTMENT IN CASE OF MSME UNITS ALLOTED LAND/SHED IN INDUSTRIAL ESTATE/AREA.

The Board of Directors of IDCO in their 99th meeting held on 25.09.2014 has decided that for pending proposals damage charges shall be realized by charging Rs.500/- per acre per day both for Large and Mega projects as well as for MSME. In case of MSME Units, which typically have less than one acre of land, shall be required to pay proportionate charges instead of a blanket charge of Rs.500/- per day.

In case of fresh proposals the Board decided to realize damage charges as follows.

SI.No.	Land value	Rate of damage charges to be realized per day per acre	Minimum to be realized per day.
1	Below 10 lakhs	0.05 % of the land value	Rs.250.00
2	Above 10 lakhs to 50 lakhs	0.05% of the land value	Rs.500.00
3	Above 50 lakhs	0.05% of the land value	Rs.750.00

This circular shall come into force with immediate effect.
