# OFFICE ORDER

The Board of Directors of IDCO in their 88<sup>th</sup> meeting held on 30.04.2011 have decided that in case of mutual transfer of IDCO lease hold property bipartite lease agreement may be executed with the transferee in stead of tripartite lease agreement on submission of an indemnity bond furnished by transferee unit.

It is decided that at the time of submission of transfer proposal both transferor and transferee are required to submit affidavits separately as per enclosed annexure- I & II respectively.

In case of all new / pending mutual transfer proposals, transferee unit is required to furnish an Indemnity Bond in the prescribed format given at annexure-III duly filled in by the transferee after issue of in-principle approval for transfer of lease hold property by IDCO.

This order shall come into force with immediate effect.
